2. There is a maximum of three shorts per filmmaker can submit but you must sign a separate release for each one.
3. Submission running time must be under 20 minutes including credits.
4. Any non English language film must have English subtitles.
5. All entries will broadcast online at www.rebelgirlentertainment.com for a period of a year or less. Drama, Comedy, Animation, Documentary, Narrative- all are welcomed.
6. Films must be submitted in final, completed form. “Rough” or “picture lock only” version will not be accepted.
7. Acceptable submission formats are DVD (NTSC, no region coding) or VHS.
8. Submitted films will not be returned. Please do not submit master tapes, master copies, or any solitary original material.
9. Submitted films must be free from any legal disputes involving rights for music and or exhibition. Rebel Girl Entertainment is not responsible for securing the rights to any copyrighted images or music used in the film, this is the sole responsibility of the submitting filmmaker.
10. Release needs to be mailed to the submission address before films can be exhibited.
11. This is a non-exclusive agreement and you retain all for your rights.
